SECTION 5.2 FILING FEES AND APPLICATIONS

All applications to the City of Willis for the approval of a proposed plat at any stage submitted to the City shall be accompanied by a filing fee of five hundred dollars (\$500.00). Applicants shall also furnish to the City additional fees as determined by the City in conformance with following schedule and the City shall not act upon any plat submitted to it unless all fees as provided herein have been received and certified by the City.
