ALCOHOLIC BEVERAGE PERMIT

Code of Ordinances

Chapter 112

- A. Applicant is required by the City to have a state (TABC) license before a city license can be issued.
- B. Applicant must show proof of their state (TABC) license.
- C. Fee for the city alcoholic beverage permit is one half (1/2) the amount of the state (TABC) fee.

PERMIT: A permit by the city will be issued upon the presentation of the state license and the payment of fees at that time.

RENEWAL: All permits shall be renewed on a bi-annual basis (every 2 years.)
